COMPLAINT

The Plaintiff, Jennifer M. Lowry, sues the Defendant, Wildlife on Easy Street, Inc., and alleges:

COUNT I - PERSONAL INJURY

1. This is an action for damages that exceed \$15,000.00.
2. The Defendant is a corporation doing business in Hillsborough County, Florida.
3. The Defendant's primary business is the operation of a big cat and wildlife sanctuary which is open to the general public for viewing and special functions including camps.
4. On or about January 21, 1999, the Plaintiff who was serving as a volunteer at the Defendant's place of business, was bitten by an ocelot, a wild cat, as the Plaintiff walked by the animal's cage.
5. At that time and place, the Plaintiff was bitten because the Defendant, Wildlife on Easy Street, Inc., negligently operated and/or maintained the wildlife sanctuary.
6. At that time and place, the Defendant, Wildlife on Easy Street, Inc., failed to properly


train, manage, and/or supervise volunteers at the sanctuary which contributed to Plaintiff's injuries.

7. As a result, the Plaintiff suffered bodily injury and resulting pain and suffering, disability, disfigurement, mental anguish, loss of capacity for the enjoyment of life, expense of hospitalization, medical and nursing care and treatment, loss of earnings, loss of ability to earn money, and aggravation of a previously existing condition. The losses are either permanent or continuing and the Plaintiff will suffer the losses in the future.

WHEREFORE, the Plaintiff, Jennifer M. Lowry, demands judgment for damages against the Defendant, costs, prejudgment interest, interest and attorney's fees, if applicable, and a trial by jury.

NOTICE OF VOLUNTARY DISMISSAL

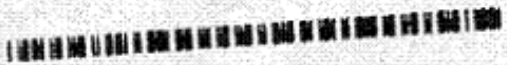
